VENDOR BOOTH PRICING: \$500 (Payment must be received payment by July 1st, 2025).

Vendor booth fee after July 1st (if spaces are available) will be \$600.

We provide the space only; vendors are required to provide their own pop-up tent, tables, chairs, unloading and loading, and anything else they need within their booth space.

Set-up will begin on Friday at 6:30am with all vehicles removed from the area by 8:30am.
